### **Article 1 - Privacy Statement**

As a company we strive to process your personal data in a legitimate, correct and transparent way. In this document we inform you which personal data we are processing and for which purposes.

#### Article 2 - Identification of the controller

In our company the personal data are only accessible for the persons who have the responsibility in their employment package and whose access is explicitly necessary to carry out their work.

# Article 3 - Identification of personal

data Several personal data are collected directly. No special category of personal data is maintained without further authorization. Cookies we use: we only use technical and functional cookies. And analytical cookies that do not affect your privacy. A cookie is a small text file stored on your computer, tablet or smartphone during your first visit to this site. The cookies we use are necessary for the technical operation of the site and your ease of use. They make sure the site works properly and remember, for example, your preferences. We can also optimize our website with this. You can disable cookies by setting your Internet browser so that it no longer stores cookies. In addition, you can also delete all previously saved information through your browser settings.

### Article 4 - Responsibility for processing

To provide certain services in a qualitative way, our firm needs several personal data as defined under Article 3 of this document. Your data is used for the following purposes, depending on the situation:

#### Article 6 - Storage of personal data

#### Article 7 - Rights of the data subject

- Right of inspection by exercising this right you can get a copy of the personal data from you that we
- Right to rectification by exercising this right you can rectify or complete your data A rectification will follow on request.
- Right to erasure by exercising this right you can request deletion of your data if incorrect actions occur in the
- Right to restriction of treatment by exercising this right you can request that treatment be limited, if incorrect actions occur or if there is a demand for improvement. This means that your personal data can only be processed with your personal data storage is not affected by this, nor any processing in the context of legal proceedings, for the protection of natural or legal persons or for important reasons of general interest.
- Transferability right by exercising this right you can request to transfer the data provided by you to third parties in a format Such a right may be limited by performing an exercise of proportionality.
